There was to have been discussions of topics that will effect every boater on the Great Lakes. For instance, the possibility of having the EPA force us to purchase a permit to regulate the discharge of gray water, and prevent us from washing our boats at dockside and possibly not even rinsing the bird deposits from our docks. (I cleaned that up didn't I) As ridiculous as this sounds, this issue was defeated last year by a narrow margin, but it is being sad that it may in fact be resurrected in the near future.

There are also issues with the State wanting to siphon our fuel tax money that goes to ODNR Division of Watercraft, and redirect it to the scenic rivers program.

These are just two of the topics that were to have been discussed, but once again apathy runs rampant!

Over the past year and a half I have attended several IOBG meetings and events. This past week, while my status was being updated, I couldn't help but notice there are a few of our Past Commodores in arrears for non-payment of dues. I'm sure this is just an oversight.
